

CEO Message

expand its outreach to maximum destitute and poorest households to serve even more in those areas. The initiatives taken by the rural communities by forming their taluka level LSO-networks in Jacobabad and Shikarpur districts are strengthening and complementing the community-driven local development.

For the up scaling and promotion of the community driven development, SRSO significantly hosted the second Community Driven Development (CDD) Conference, at SRSO complex, Sukkur. This conference provided a platform for the rural organized women to share their experiences, their local development initiatives, and their future aspirations through community institutions. The valuable and credible partnership with the USAID has also opened up the new avenues of the long-term working for the Non-Formal Education, playing a pivotal role in providing the non-formal education in rural areas. The UNICEF's highly significant support under the child rights context has also been helping the communities in cotton farming areas of Ghotki and Khairpur districts. The highly valuable partnership with Brooke for the equine welfare project, HelpAge International for the Big Lottery Fund project, PPAF for the IFL project and Government of Sindh. These partnerships have been remained the great source of strength and viable support for the rural communities. In the context, SRSO acknowledges the due proportion of its each partner's support for the joint cause, and also remained thankful to them for continued efforts and crucial support in making the difference, throughout the reporting period. The Craft Enterprise Development sector has tremendously maintained the core values of consistent linkages with the rural communities.

SRSO Background and Introduction

SRSO was established as a Company limited by guarantee in 2003. The setting up of the SRSO was triggered due to recognition of the success of Rural Support Programs (RSPs) which was initiated by the Aga Khan Rural Support Program (AKRSP) from the Northern Areas and then replicated into provincial RSPs across Pakistan. Thanks to the provincial government of Sind for providing seed capital to SRSO which has laid a sound foundation of the organization to sustain its core function and at the same time leverage this capital access donor funds for various development projects.

The goal of SRSO is to improve quality of life of rural poor in Sind. To achieve this goal, SRSO attempts to harness peoples' potential through a social mobilization process which has been designed on the core assumption that people have tremendous potential and willingness to improve their quality of life. The objective of SRSO is to develop a building block of community institutions at the settlement level, village level and Union Council level in all the union councils of its Program districts. While the settlement level institutions i.e. the Community Organization (CO) enables the member households to

participate in developmental activities, the village level and union council level institutions namely the Village Organization (VOs) and the Local Support Organizations (LSOs) help the COs in raising their voice at a higher level which enables the member households in accessing various services by linking with the government functionaries and donors. The COs take care of household level activities, while the VOs and LSOs manage larger projects through their COs at village and union council levels. The LSO and VOs also play an important role in strengthening the COs and increasing Program coverage. SRSO offers two packages to the community. 1) Conceptual and 2) Program package. Conceptual package revolves around organizing them into the fold of above structures to understand their inner potential. This develops internal capacity in terms of unity, self-help initiatives, confidence and passion to attain economic development. Once organized and groomed through training, they are offered program packages which includes capacity building opportunities, small scale physical infrastructure schemes. revolving funds etc depending their MIPs and organization's resources.

Community Driven Development through Social Mobilization

It has been globally recognized that by directly relying on poor people to drive development activities, CDD [community driven development] has the potential to make poverty reduction efforts more responsive to demands, more inclusive, more sustainable, and more cost-effective than traditional centrally led programs...achieving immediate and lasting results at the grassroots level.

For the last 13 years, Sindh Rural Support Organization has been working with the noble mission of mobilizing people for communal Harmony in rural upper Sind with the same CDD approach. To achieve this, various development programs have been implemented in accordance with local priorities

of the communities for positive change in their life style. Union Council Based Poverty Reduction Program funded by GoS, PPAF funded HID, CPI, Micro Credit and LEP project, and now Sindh Union Council and Community Economic Strengthening Support Program (SUCCESS) funded by European Union are some of the major programs that have and will continue contributing in bringing significant change in socio-economic conditions of the poor. However to give a new impetus to the on-going development programs, SRSO keeps striving to build capacity of the community networks formed at grass root level and continues lobbying with Government and International Donors for resource mobilization.

SRSO Outreach

After 2009 when UCBPRP was launched, 2015 was yet another year which enriched SRSO's outreach in rural areas particularly in two of the most deprived districts i-e Larkana and Kambar Shahdadkot.

By the reporting year (as of June-2016), SRSO has reached out 600,921 rural households in 11 districts, 52 taluka, and 395 rural union councils. Under the three-tier social mobilization approach, SRSO has formed 130 Local Support Organizations (LSOs), 7,429 Village Organizations (VOs) and 37,607 Community Organizations (COs) in aforementioned eleven districts.

With the support of donors and creating community linkages with other funding sources, SRSO prominently extended tremendous viable support to the rural poor organized households who are willing to make the best use of their innate potentials through MIPs. As of June 2016, a total 1,064 million have been disbursed as Community Investment

Fund (CIF) benefiting 101,702 poor households to start up their small scale business operation for adequate livelihood. Besides, under the Micro Credit Program, 451,783 households have been provided small livelihood loans of total 8,058 million, since inception.

In order to safeguard the poor households from the health-related shocks, 619,197 rural households including staff members have been insured with different renowned insurance companies. SRSO has extended 40,189 small scale community physical infrastructure (CPI) schemes including construction of low cost houses, communication, sanitation and drinking water schemes. This sector has benefited 235,856 households in improving mobility and economic activities in such remote areas.

Social Mobilization III by PPAF.

SRSO and Pakistan Poverty Alleviation Fund (PPAF) entered into an agreement and executed the SM project in District Ghotki in July 2008. The objective of the SM project was to Increase the footprint of social mobilization by organizing the poor and poorest rural households (women and men) in program districts. In June 2013, the project completed its 3rd phases and finally ended up in September, 2015 with achievement of organizing 7,371 Community Organization (COs) representing 123,032 poor households with their federation in 1,136 village organization and 12 local support organizations who are managing their own development through transparent, equitable, inclusive, accountable and community demand driven processes.

Through Human Resource Development, A total of 12,258 CO members, 1,702 VO members and 49 LSO members have been trained on Institution management and planning which has brought meaning to the process of social mobilization. Other major achievements of the project include preparation of 120 Village Development Plan (VDPs), training of 600 activists on basic civic and constitutional rights, conducted 40 issue based workshops organized on girl's education, functioning of schools in which more than 600 people participated, training of 196 members in disaster response management and 450 members on linkages development and resource mobilization.

Livelihood Enhancement & Protection (LEP) project by PPAF



Livelihood Enhancement and Protection (LEP) project is one of the most important partnerships between SRSO and PAF. The livelihood project started in 2011 and completed its 2nd phase in September 2015 at Ghotki District. The project featured some of the new interventions which really was a risk to introduce given scenario of poverty, less relevant experience. Luckily, these were not only successfully done but also brought tremendous boost in income generation of the poor and their poverty level gradation.

These activities were assets distribution upto worth PKR 50,000, introducing cross breed livestock for more milk and meat productivity, introducing technology of artificial insemination and setting up mobile veterinary clinics etc. Project also helped in developing technical and vocational skill enhancement of youth through its huge training portfolio. Over all, following major milestones were achieved which increased community incomes at larger level:

- * 1,196 cross breed heifers have been distributed in poor women of district Ghotki.
- * 513 local breed cows have been distributed among the poor women.
- * 178 other eligible women have been provided assets of karyana shops, puncture shops and other assets of their choice as per their LIPs.
- 8,638 Female members have been provided trainings on livestock management, agriculture management and enterprise development.
- 878 youth have been provided vocational trainings under various trades of their choice through well reputable institutions.
- * 22 willing youth members from poor households have been imparted technical training on artificial insemination (AI) technology from well reputable institution of Lahore.
- * 133 Common Interest Groups (CIGs) of poor women are formed.
- * 1,897 animals have been treated and 1831 animals vaccinated through mobile clinic.
- * 71 animals are provided A.I facility by SRSO trained technicians.

Community Investment Fund (CIF) under Maintenance Phase of UCBPR Program

In 2009, Government of Sindh through SRSO initiated pilot project with the name of Union Council Based Poverty Reduction Program - UCBPRP with an aim to uplift social and economic life of poor in three districts Shikarpur, Kashmore @ Kandhkot and Jacobabad with the total cost of Rs 4.3 billion.

The Program is totally aligned with the Rural Support Programs (RSPs) conceptual package of social mobilisation. In addition to that, program package was also designed very carefully considering all basic indicators and its connectivity that could help in achieving best results to cater poverty and related issues.

This activities included 3 tier social mobilization, capacity building of community in terms of improving their managerial, financial, record keeping and technical and vocational skills, provision of small scale physical infrastructure schemes, financial grant, education and health.

Among all above, the most important

intervention was setting up of a village based revolving fund at the community level called "Community Investment Fund" (CIF). Since 2009 till date, PKR 996.85 Million has been disbursed by SRSO under GoS funded UCBPR Program and from SRSO core funds. This revolving fund is managed by village organizations that provides interest free livelihood loans to poor member households. After a significant time of almost 7 years, community institutions, with support of trained community resources persons are efficiently managing and revolving CIF with focus of covering maximum uncovered households in multiple cycles. LSOs are also supporting Village Organizations in verifying eligible beneficiaries, guiding them for appropriate utilization of CIF in light of their Micro Investment Plans – MIPS, capacity building in monitoring and record keeping etc. Till reporting year, following is the status of CIF being revolved and re-disbursed:

Impact Assessment of CIF by Sukkur IBA

Since CIF is designed and disbursed as a revolving fund and is managed by community organizations, SRSO still keeps on monitoring it periodically and reports it to Government of Sindh. During the reporting period, SRSO

hired consultancy of Sukkur IBA to conduct impact assessment of CIF in three districts: Shikarpur, Kashmore-Kandhkot and Jacobabad.

Abstract of Study.

The study focused on measuring impact of CIF in terms of poverty reduction(mainly) and its other indirect benefits like women empowerment, women's mobility, awareness on importance of other social indicators like health and education, peace etc. Randomly selected sample of 2,520 CIF beneficiaries from 03 districts were surveyed and in order to ensure relevance of results with program intervention, 500 households were also surveyed from control group having same features and vicinity. Based on the results of survey on poverty scorecard tool, a significant graduation is observed across all districts. According to old PSC band (2009-10) scores

of 2,258 selected sample there were 1,220 beneficiaries in Band-I (0-11) and 1,038 in Band II (12-18) which makes a 54% and 46% of the total sample respectively. In the current year's survey, it was observed that 799 BHHs from 1st band (0-11) and 777 BHHs from 2nd band (12-18) have graduated from their previous bands directly to the 4th band of poverty scorecard which is 23 - 100 certainly called non poor. Study also compared graduation of households who received other interventions or did not receive any intervention at all (control group). Results came as under:

Significant change in other socio economic indicators was also observed during survey. Amongst all sampled groups, better intake of healthy food, more number of Pakka houses, better participation in household decisions such as utilization of household income, decision of children education, sale purchase of household assets, involvement in decision of children's marriage is reported in CIF beneficiaries. Increased women mobility and participation in electoral process and social gatherings is also reported in CIF beneficiaries.

The findings of improved socio-economic conditions and high graduation rate from extreme poverty to upper levels suggest that the intervention of the community investment fund (CIF) has been successful in achieving its objective. The results of this study further warrant the continuity of this program and its extension to other districts.



Local Support Organization (LSO), the 3rd tier of Social Mobilization



SRSO is on the way to accomplish the community empowerment and development by polishing their innate potential within scarce resources. One of vital pillar driving the rural development is community development by managing, organizing them at community level institutes by strengthen their institutes' that they can lead their organisation for their development.

SRSO has a unique ownership structure of community empowerment that is joint efforts of SRSO and community leaders which raised their voice for their rights and now they are on progress track. Now organized community have more comprehensive agenda which includes greater recognition of their efforts politically, socially and economically. This has increased the community living standard by creating livelihood opportunities and awareness and helps people gain better access to all basic services. Based on community's efforts, following milestones have been achieved by LSOs during reporting period:

- * LSO have established their own offices at community level which have proven as a hub for community coordination and intervention for other departments for building linkages
- * LSOs have built linkages that they have opened new private schools on grant from different organisation.
- * LSOs have proved a key community pillar for other organisation to work in these concern areas like save the children has recognized Shikarpur LSOs as their coordination offices for immunization and vaccination of mother and child.
- * LSO has opened NFE centers in their community with the support of SEF (Sindh Education Foundation) and Brac Pakistan
- LSO Office Bearers are working in Health Department as an LHV and LHW.
- * LSO Office Bearers have won the local Government Elections on different UC levels i.e. Counselor, Chairman and etc
- * 4 LSOs of Shikarpur and Jacobabad received Achievements Award for self reporting throughout year from PPAF.
- * LSO members participated in different Seminars and events of across Pakistan and shared their stories from the journey from beginning to success.

Sindh Union Council and Community Economic Strengthening Support (SUCCESS) Program

The rural communities of Sindh province suffer from critical socioeconomic conditions which result in high prevalence of extreme and chronic poverty rates. In this context, in 2008, the Government of Sindh (GoS) launched the Union Council **Based Poverty Reduction** Programme (UCBPRP) in four districts of Sindh through Sindh Rural Support Organization and Thardeep Rural **Development Program** - TRDP . Comforted by the positive results achieved through the social mobilisation approach of RSPs to community driven development (CDD), GoS intends to scale up the programme. To support GoS in the scale up, the European Union (EU) has launched the 'Sindh Union Council and Community **Economic Strengthening** Support' (SUCCESS) Programme in 2015.

Launching of SUCCESS Program


SRSO formally organized the launching ceremony of European Union (EU) funded SUCCESS Program on 29-March-2016 at the auditorium of SZABIST in district Larkana, Mr. Ghulam Akbar Laghari (Commissioner Larkana Division) honored the ceremony as chief guest. Mr. Shoaib Sultan Khan (Chairman SRSO), Mr. Fazalullah Qureshi (BoD member SRSO), Mr. Mohammad Ali Bhutto (MPA), local notables, elected representatives, local political leaders, representatives from different walks of life and community members from Larkana have also participated in the ceremony.



Achievements during the Financial Year 2015-16

After signing a formal agreement with the European Union (EU), SRSO started inception activities under the SUCCESS Program from February 01, 2016. During the reporting period, 9 project offices (1 PIU, 2 District and 6 Field Unit Offices) were set up. 115 professional staff was recruited which was trained in orientation training SUCCESS, its Program Implementation Manual (PIM) and

Community Awareness Toolkit (CAT) and M&E Framework. After recruitment and office set up, field work started with poverty mapping through poverty Score Card Survey which was carried out under supervision of core M&E Sector by using Computer assisted personal interviews (CAPI) tool. 13,123 households are organized into 764 newly formed Cos in both Districts.





Prime Minister's Interest Free Loan (PM-IFL)



PM-IFL is the microfinance program initiated by Government of Pakistan (GoP) for the socio-economic development of poor and small scale business holders. SRSO has entered into a partnership with PPAF-LEED Group for implementation of Prime Minister Interest Free Loan Scheme amounting Rs. 120 Million. It is a revolving loan facility for a period of four (04) years. The loan will be revolved by SRSO through its branches / Loan Centers, in 12 Union Councils of Ghotki, Kashmore-Kandhkot and Shikarpur. After completion of project tenure, this amount will be transferred

in LSOs account as grant from Government and they will further utilize same amount as revolving fund in same manner.

The loan is given to the poor's those who scores between 0-40 on the Poverty Score Card for either start of new business or expansion of any existing one. Community needs are determined from MIPs. Participation of women in loan through community level institutes', will enhance their experience and opportunity of self-employment.

Micro Finance



SRSO's Micro Finance Program is running successfully since 2004. Over the time, Micro Finance program has served the needs of low-income households and has also played the role to help the poor to get out of the clutches of private money lenders and traders. The dynamics of SRSO microfinance is the informed choices to the clients, business counseling according to market needs, onsite technical assistance, marketing assistance for

growing enterprise, flat affordable service charge and life insurance coverage. **Potential Clients:** SRSO believes that the women are more active and responsive as compared to men Women takes part in program activities with interest as they see and evaluate benefit in a whole family's perspective. Based on this philosophy, 88% of MF clients are women.


Sector wise MF disbursements

Micro Finance mainly offering loans to its clients in three conventional sectors i.e. Agriculture, Enterprises, and Livestock. The utilization of amount is consistently reported in aforementioned sectors from rural and urban areas. Brief detail as under:

Enterprise: under this category the willing clients who mainly residing in urban and semiurban settlements/areas are being provided micro credit facility. During the reporting period a total of Rs. **515,039,000** have been disbursed in **20,833** potential clients for the strengthening of enterprise development. These loans are either used for setting up small enterprises or expansion of existing enterprises of the beneficiaries. Potential beneficiaries from SRSO vocational skill training program are also linked with enterprise loans. In reporting year, percentage of enterprise loans remained 35% of the annual disbursement while overall 17% MF portfolio has disbursed in enterprise loans.

Agriculture: Farmers and small landowners are potential clients under this very crucial category. This is entirely rural portfolio of MF where masses have insufficient financial support to purchase inputs for cultivation. During the year, 31,253 potential borrowers have been provided loans of amounting Rs. 737,059,000. Current year the portfolio of disbursement in agriculture remained 50% however it is 71% of the cumulative disbursement since inception of MF program.





Livestock: Case studies have revealed that Community women demonstrate their best ability in utilisation of micro-finance services through livestock. During the reporting period, a total of Rs. 217,082,000 is disbursed in 9,827 eligible borrowers in livestock sector. Percentage of loans disbursed in livestock is almost same every year which is 12-13% against annual and cumulative disbursement respectively.

Capacity building of field staff:

Following the previous trend, capacity building of field staff remained on high priority this year too. This activity helps in preparing team for overcoming possible issues and challenges to save MF portfolio. Training on portfolio management, Credit Appraisal and Recovery Techniques (CART) and MF Annual retreat were the main capacity building events during reporting year.

Social Sector Services (Education-based projects & activities)

Education Component of SRSO

The functioning of specific 102 non-functional government schools was decided in the year2009 when the GoS funded UCBPR Program was launched in Shikarpur and Kashmore districts. Project aimed at re-functioning closed schools along with provision of missing facilities, improved enrollment and retention rate and quality education.

In order to ensure sustainability of these schools, SRSO has engaged communities through their Institutions for regular

monitoring. Village Organizations (VOs) are usually responsible to check regular attendance of teacher, students, meeting with parents ad SMC when required while LSOs are responsible to look after things at broader level which include surveys at Union Council level to assess functional and non functional schools, availability of teachers, enrollment campaign and liaison with local line



departments for availability of missing facilities in schools.

The involvement of community institutions have created ownership and its putting an exceptional impact on education based activities. Efforts are being continuously made to ensure 100% enrolment by controlling dropout of children and with provision of quality education.

Community Cluster Schools

After functionalizing 102 primary schools under GoS funded UCBPRP project, the need for middle level schooling together with secondary education emerged which was not existing in current geographic project area of 28 Union Councils in district Shikarpur and Kandhkot Kashmore. SRSO alongwith community realized it soon after first batch of primary school passed out. To cater the need, SRSO proposed Government of Sindh for consolidation of primary schools in cluster schools. Soon GoS approved the scheme and 9 community cluster schools were established in 3 UCBPRP districts including Jacobabad.

These Cluster schools are aligned with the policy of the Education Department, Government of Sindh whereby a full complement of school facilities have been provided in one central school through consolidation of the adjoining schools in the vicinity. It became easier to provide teachers,

head teacher; other inputs like computer education; Science laborites and libraries in a cluster and consolidated school rather than in numerous one/two room schools. These schools are supervised by village and Local Support Organizations for quality check and sustainability.

In the reporting year, SRSO through community, established Science labs in Cluster Schools. In SRSO rural areas, electricity power failure is on peak especially in summer. To address the issue, SRSO took special initiative of installing Solar Power Plant in Qabalo Cluster School. In addition to these arrangements, 90 teachers from cluster schools were provided residential training on the modern tools, techniques, and effective teaching methodologies through IBA.

Non Formal Education funded by the USAID-SRP



SRSO in the year 2016, entered into an agreement with the USAID Chemonics to Implement Sindh Reading Program's component 4, "Non Formal Education" in selected areas of District Kashmore and Jacobabad. Project aims at enrolling out of school children between age groups of 10-15 years in established NonFormal Education centers.

SRSO established 67 NFE centers (34 in Kashmore and 33 in Jacobabad) and 2,000

out of school children have successfully been enrolled. Besides enrollment, 67 local teachers have also identified and hired by SRSO. These teachers have been through a five-day teachers training in which they learnt newly developed teaching material. The initiative taken by SRSO with the financial assistance of USAID has paved out a way forward to continue serving and promoting 100% literacy in these areas in years to come.

Health Communication Component (HCC)



In rural Sindh, basic health necessities are miserable and totally disarrayed in public hospitals. Non-availability of doctors, resources, medical advice and lack of medicines has led to rise in mortality rates. In addition to the services, lack of community awareness on health practices and danger signs of some chronic diseases is yet another grey area which



has increased incidence of ailment and mortality especially among children, pregnant and lactating women. SRSO's Social Sector section through its Social Mobilization approach and with financial support from different donors, supports organized community to overcome the challenges they face in this key area.

SRSO partnered Johns Hopkins Bloomberg School of Public Health Center for Communication Programs (JHCCP) through RSPN to implement project on Health Communication Component - HCP. The objective of HCP project is to create awareness on Maternal Newborn and Child Health-MNCH, Reproductive Health and Family

Planning. During the reporting year, project activities focused on community awareness raising through trained

community health workers, coordination with health line department and other stakeholders, celebration of different events to spread message to the maximum recipients and supporting GoS department in EPI program outreach specially in non covered areas. Project is being implementing in Sukkur, Sanghar, Shikarpur, Larkano, Ghotki, Noshero feroze, and Jacobabad districts.

Health Systems Strengthening Project (HSSP)



Under the Health System Strengthening (HSS) Component of USAID funded Maternal and Child Health (MCH) program, SRSO in partnership with RSPN-JSI has implemented the activities with community organizations to improve health services and advocacy in Jacobabad and Kashmore districts. In these districts SRSO with the help of Local Support Organizations created a trained cadre of Community Resource Persons (CRPs) as volunteers. Through these volunteers and with the technical support of SRSO, children under (0-23) months and pregnant women got registered and vaccinated.

SRSO with the support of Extended GoS Immunization Program has developed micro plans and ensured the vaccination of all these registered children's and pregnant women. To raise awareness on importance of immunization and to create its demand at community level for the services, SRSO through CRPs organized community awareness sessions. It helped to sustain card retention rate at the community level. SRSO also hold district level workshops in order to appreciate the efforts of district level stakeholders involved in improving the routine immunization in these districts. The events were participated by elected representatives, district government officials, district health department officials and vaccinators and SRSOs management and staff.

Community Health Micro Insurance

SRSO's community Health Micro Insurance is a Program that provides health insurance cover to the poorest of poor in SRSO operational areas. The program aim at playing a bridge role between community and Insurance companies to reduce burden of medical expenses on the poor and resources are pooled to mitigate health risks, cover health care services in full or in part and increase accessibility to quality hospital care. SRSO started Health Micro Insurance program in 2007 from small coverage while it expanded to scale in 2009 when GoS provided free Health Micro Insurance to the poorest of poor under Union Council Based Poverty Reduction Program - UCBPRP in two districts Shikarpur and Kandhkot Kashmore. Program has benefitted more than 450,000 households providing insurance cover to approx. 1 million

headcounts. In result of the program's popularity in terms of its benefit to the poor, this intervention has also been replicated/added with even better added features in European Union -EU funded SUCCESS project signed in reporting year.

SRSO Health Micro Insurance has multiple packages for the community depending on their needs which covers individuals to the whole family members. In addition to providing health insurance cover, this program also imparts health awareness sessions and facilitates free medical camps through linkages. Panel hospitals with quality medical services are enrolled at tehsils and district levels with the help of service providing insurance company.

Natural Resource Management (NRM) plays a significant role in active engagement of rural masses which produces the increased productivity and establishes viable livelihoods. SRSO NRM section deals with agriculture, livestock, micro-drip irrigation systems and backyard kitchen gardening. Section is also putting efforts to capacitate poor farmers on modern and innovative technologies for the income generation purposes through massive productions and women who are associated with livestock management.

During the reporting period, NRM section promoted poultry layering and kitchen gardening for poor women that can value

Agriculture Awareness Workshops

Through the workshops on the agriculture, community's knowledge on various crops and plants they have been planting since years in the current scenario is enhanced. In these workshops, beneficiaries are informed about the various verities of seeds, for the better productions, latest tools and techniques in order to get the maximum yield with minimum

add to their lives and financial situation. This meaningfully allowed rural masses to plan possible use of their resources in an efficient manner. Keeping in view the current trend and modern techniques Organic horticulture, or organic gardening, has become increasingly popular for the modern home gardener which has been rapidly replicated at home level as the kitchen gardening. NRM has provided all the material: seeds, tool kit and training to poor rural women to encourage them for successfully implementing the kitchen gardening and promoting it among community. This has proved quite effective for rural households in terms of food security.

expense and awareness on cultivation of different types of seasonal and off-seasonal vegetables through the various methods. Besides this, NRM section also capacitate farmers in establishing direct linkages with local markets without the involvement of any middleman.

Based on the principle decision of SRSO management, the activity of tree plantation initiated in all operational districts of SRSO. This activity was started in 2013 and remained in progress until reporting period. NRM team remained highly engaged with organized community in various villages to facilitate them for the successful launching of Tree Plantation campaign in rural areas. Initially, SRSO provided seed-plants to the communities to carry out the campaign, later community has adopted as well as owned the entire initiative and promoted it at a larger scale under the core benefit of their rural areas. In initial phases, the women members showed great interest and planted trees in their homes and nearby areas and other public premises like BHUs, schools, guesthouses, mosques etc. During the reporting period, a total of 459,800 tree-plants have been planted in different areas and villages of SRSO operational districts.



It is intended and mentioned in the five-year plan, that SRSO will plant more than 1,000,000 trees in remotest areas, in order to enable the rural masses to sustain as well as combat the impacts of climate change caused by numerous factors.

Equine Welfare Project by BROOKE

From 2008, equine welfare project namely the BROOKE project is being implemented in four districts i.e. Shikarpur, Jacobabad, Larkana, and Sukkur. The project mainly aims at promoting and ensuring adequate welfare for the working animals' especially equines. Among equines, donkeys and mules are animals which suffer from a lot of issues during work or at the household level. Besides, being working animals, they are also the source of livelihood in many urban and rural areas for the poor households.

SRSO and Brooke are jointly striving to convince the animal owners to ensure at least the reasonable care of their working animals with prescribed measures in a daily routine specifically after working hours. In order to achieve the possible animal's welfare, there is a chain of various activities being carried



out in the field with equine owners, farriers, and saddlers. To that purpose, all the stakeholders are being sensitized to contribute effectively in shape of their efforts/support, as the equine welfare purpose could be served efficiently.

Achievements by the Financial Year 2015-16

During the reporting period, a full-time dedicatedly spared mobile veterinary clinic visits in the field and provides required and emergency treatment to the equines. During the year 2015-16, a total of 18,125 animals have been treated, dewormed and vaccinated. Besides regular treatment, 526 meetings have been organized with communities to make them aware of the basic management practices at the household level, while

managing the equines. In order to ensure the easy access and availability of drinking water for the working animals, during the reporting period, 19 fixed water troughs and 14 portable water troughs are installed at the nearby sites/areas where the equines are normally working.

In addition to aforementioned activities, project team also arranged 04 healthy animal competitions in which healthy and active equines participated. This activity allowed owners

to showcase the energy and strengthens of their animals to win the competitions at their best. Also attracted the other equine owners/users to adopt good health measures for their animals to become eligible for the healthy animal competitions. This activity largely proved very effective in terms of animal's health and management.

For the maximum promotion of equine's welfare, 46 women equine welfare meetings were arranged in all project districts.

Age Friendly project by Big Lottery Fun (BLF) and Helpage International



SRSO in its struggle for poverty reduction, believes in inclusion of all segments of life. Senior Citizens are part of this whole struggle who can never be ignored. SRSO has been working with partnership of Helpage International for about 6 years now. It focuses on wellbeing of older people by engaging them in not only social mobilization process but also by providing them direct benefit through special age based interventions. Project named as "Empowering Older People to improve their lives" is funded by Big Lottery Fund (BLF) for 3 years in Jacobabad and Shikarpur District of interior Sindh. This Project has vitally focused on strengthen the voice and livelihood strategies of older people. Under this project, 5,000 Older People (OP) have approached to contribute in decision-

making at district and provincial through OPAs membership that has engaged and influence local authorities, financial and social protection institutions to better address the needs of older people. This project has assisted 1000 older people to access existing social protection, microfinance, and wider livelihoods support programs. Furthermore, 2,000 OP (older People) received microfinance credit and age appropriate livelihoods skills training to better enable them to reduce their poverty by increasing their incomes and meeting their food and other priority basic needs. This strength will be used by OPAs to support their advocacy work pushing for policy change within government, financial and social protection institutions.

Sindh Rural Support Organization

The project activities are being conducted with 6,822 active and regular members including 3464 older women (50.77%) and 840 persons with disabilities (12.31%) in 107 Older People Associations- OPAs. All OPAs are federated at the district level and their federations are actively working for the rights of older people.

Paralegal support services is another component of the project: Paralegal workers/volunteers from OPAs are trained on paralegal support services. A network is developed with different Human Rights

Organizations, District bar Associations and Human Right Activists in the project area. A referral mechanism is agreed with network members for paralegal support services.

Older Persons and Persons with disabilities have been supported to access their existing entitlements at various government and non-government social protection institutes for getting entitlement from Zakat and Usher, Pakistan baits ul-Mal, Benazir Income Support Program.

Achievements by the Financial Year 2015-16

These advocacy efforts and OP (older People) have successfully achieved a big milestone that on 29th April 2016, Sindh Assembly passed "The Sindh Senior Citizen Welfare Act 2014" for older persons of Sindh Province. The Act is a result of advocacy campaign run by OPAs/Federation with parliamentarians, government officials, local politicians, representatives of local bodies and other stakeholders.



- * An important notification has been issued by Deputy Commissioner Shikarpur and notified the aging focal person in the district.
- * State Bank of Pakistan issued special directives to all commercial banks and microfinance banks to stop discrimination against senior citizens in opening bank accounts and other banking services including the issue of ATM cards.
- * Older People Associations (OPAs) have successfully got community development schemes in their villages from different government departments and local and international organizations.
- * 500 OP/PWDs were given microcredit on easy installments of six months /one year with interest rate of 10%. (10% for Livestock and Entrepreneurship while 5% for agriculture loan having return period 6 month). Microcredit is given to OP/PWDs for three categories, i-e; Agriculture, Entrepreneurship, and Livestock.

Gender and Development

The overall situation of Sindh women is marked by persistent gender inequalities. Sindhi women lag behind men in terms of health, literacy, productivity, social and economic status.

SRSO firmly believes that unless gender related inequalities are addressed it will not be possible to achieve mission of poverty reduction. Balancing the unequal power between men and women cannot be done in isolation. For the development process to be gender-fair, change will have to take place in the economic, political, social and cultural spheres. Ensuring that women and men are able to fully utilize their potential particularly

in the development process is one of the top priorities. SRSO has always been actively involved in empowering women. Its whole program philosophy revolves around women who is believed to be the central and most integral part of any family. For last 7 years, prime beneficiary of SRSO interventions has been women. The journey begun with implementation of UCBPRP program which was 100% women led program and till now, it is well headed by women. Overall SRSO's every intervention revolves around women but following are some specific gender related activities carried out in reporting year:

Annual Achievements:

- * Community these based Gender sensitization workshops were organized in which 550 male community members participated.
- * Gender sensitization sessions for SRSO auxiliary staff special workshops for Professional staff were organized based on the understanding of gender concept, Islamic perspective, principles of gender in development and basic tools of gender analysis.
- * To ensure conducive working environment, awareness sessions on Women Harassment Act 2010 were organized for Management and professional staff.
- * Celebrated 2 events on International women's days; 3 events on international Mother's day, 3 seminars on international Human Rights day and different advocacy material was published and distributed at community level.



Physical Infrastructure and Technology Development (PITD)

Rural areas of northern Sindh lacks basic infrastructure like roads, drinking water facility, sanitation etc. This lacking hinder poor's access to the local markets, schools, hospitals and other public/commercial facilities which ultimately affects local economy and increase poverty. SRSO, for last 13 years, has been working on community based small scale physical infrastructure schemes with financial assistance from multiple donors and SRSO core funding as well.

The triumph of community-based physical infrastructure schemes is always associated with the complete engagement of organized community members with firm ownership. SRSO implements schemes through plateform of organized community institutions (CO/VO) and also engage community members in whole process starting from identification of the scheme till its completion and even for operation and maintenance after completion.

During the reporting year, PITD section implemented schemes of low cost houses and construction of community cluster schools funded by GoS and also completed some ongoing schemes funded by PPAF-PPL. The

Construction of cluster schools:

based on the survey and estimated cost i.e. 50.477 million, SRSO started the working on the six community cluster schools with the financial assistance of education and literacy department, Government of Sindh. The physical work on schools was started in 2014 and completed during the reporting period in Shikarpur and Kashmore districts. In result of massive utilization of funds, the following facilities are provided in schools for students. 12 classrooms, 01 computer laboratory, 01 science laboratory, 01 pantry and 01 store. On the pilot basis, one cluster school is fully equipped with the facility of the solar system as an alternative energy supply to overcome the issue of load shedding and to provide an effective learning environment.

Construction of low-cost houses:

under Benazir housing cell (BHC) project of P&D GoS, 500 low-cost houses are constructing in two districts i.e. Jacobabad and Shikarpur.

The project started in 2014, by the reporting period, construction of 488 houses initiated, whereas 257 houses are successfully completed and occupied by the beneficiaries. The specification and designed is based on the rural dynamics including two rooms (size of 12 by 10) with front side veranda. The entire house is fully plastered internally. House is also extended with the construction of flash latrine and complete flooring of the house. Doors and windows are designed in such a way which makes the entire house ventilated.

The payment of house is released in three trenches i.e. Rs. 45,000 on plinth level, Rs. 67,500 when the work is completed up to the roof level and final trench of Rs. 67,500 is released when the construction work is fully completed and occupied by the beneficiary. The payment is released based on the physical verification and acknowledgment of concerned





field engineers who certify the level of construction of work.

Rescue and Relief operation during flood 2015

in 2015, katcha areas of Sukkur, Khairpur, Kashmore-Kandhkot, and Shikarpur were affected with floods. SRSO PITD section responded immediately for provision of critical WASH services to flood-affected populations. WASH interventions were focused to reduce incidence of water and sanitation related diseases through the provision of safe drinking water & adequate sanitation coverage. Major activities carried out are as under:

- * SRSO provided the basic necessity items i.e. non-food items, soaps and cloths.
- Vaccination, treatment and Deworming activity for livestock was done in affected areas
- Provision of safe drinking water to extremely flood affected households living in flood affected villages, and spontaneous camps (as per the assessment) through the installation of hand pumps.
- * Provision of adequate sanitation facilities in flood affected villages and camps with the construction of emergency pit latrines.

Crafts and Enterprise Development Handicrafts give rural women a helping Hand

SRSO believes in empowering the rural women to improve the livelihoods of rural women. Recognizing that the community's meager agricultural production was not providing sufficient income, so craft of hand made products is a source of alleviating the poverty because mostly women in rural areas women busy in agriculture and livestock but they are hereditary good at home made work, only need to polish their skills which can make them a pearl of society. Women are cultural brand ambassador because Sindh is rich in culture so, in this perspective SRSO-Crafts Enterprise Development (CED) sector has made them skilled women by building the

skills of artisans in some handicraft arts, quality assurance and fine products finishing to provide new income-generating opportunities for promoting ethical fashion in the operational

areas of SRSO. CED offers various things to artisans: skill upgrades, design workshops, market linkages and awareness programs to help the artisans enhance their expertise. CED- contributes in achieving overall goal of SRSO regarding poverty alleviation by increasing income generating opportunities for women artisans.



Business Development Groups (BDGs)

Idea of making BDGs is to organize artisans in groups for larger orders which certainly gives them increased income. These groups are easier to capacitate in different skills for product quality improvement and also brings market closer to the artisans which is difficult while working as an individual. There are 129 BDGs formed till reporting year which are linked with market and mostly getting good size of orders.

Community Based Product development Workshop:

Capacity building of artisans for quality improvement and value addition to the existing craft as per current market need is one of the main activities which CED section deals with. Since inception, hundreds of artisans have been trained on various subjects. 220 artisans from 20 BDG's were trained on marketable product practically for future business

production in reporting year. Besides, CED and artisans together develop new products after exposure of markets through different exhibitions kind of events.

Promoting Culture & fashion through Organizing Exhibitions and festivals.

SRSO-CED has always tried to bridge gap between community and actual market from where the opportunity of income has to be grabbed. For this, SRSO from its part contributes in organizing and even identifying and linking BDGs with events like exposure visits, exhibitions fairs etc. it gives women artisans confidence, idea of market need, comparison with other's product and skill of

marketing. IN addition to the participating in external exhibitions, SRSO has successfully introduced its brand called "Sartiyoon Sang Annual Festival". This is a 3day mega exhibition organized at Karachi every year. Response of buyers and BDGs both is increasing with each passing year resulting increase in BDGs income.

Community based production Centers

CED has taken a new initiative for community by establishing the community based production centers to promote the village brand in market to promote the cultural and ethnic fashion after the demand of BDGs' to provide a platform, where all the raw material (machine & accessories) for products at community based. SRSO started this initiative

in BDG Masan Mohalla and Rahooja in Sukkur District where 35 artisans under the one roof sit together for making products, Product Designing and Finishing.

Institute of Management and Skills Development (IMSD)

Institute of Management & Skills development is an intra-training house for staff and community that is directly linked with the organisation to enhance and build capacity as per modern techniques and adept in all fields. The IMSD seeks to provide learning opportunities for all staff so that by performing their individual jobs effectively, they can contribute to Organisation's Mission, Vision

and Values. IMSD aims to unlock the true potential of the community poor rural women through a variety of training Programs to eradicate poverty, reduce inequality and improve the quality of life of the rural communities by empowering them to harness their true human, social and economic potential.

During the Year, IMSD has performed following activities

- * OTW for newly hired staff of SUCCESS Program at Head Office.
- * Community level training for managed and organized community (CMST & LMST) by developing their training material under SUCCESS Program.
- * 3 days TOT for HRD officer of SUCCESS Program.
- HELPAGE Project's Agriculture and livestock training for OPA and number of pax by developing their training material at community and Head Office level
- * Signed a new agreement about vocational training for the youth of Sukkur with NAVTTC (National Vocational & technical training Commission) for 6 months Program.
- * Capacity Building training of Microfinance sector staff on CART (Credit & Recovery Techniques).

Child Rights in Cotton Farming Areas (CRCFA) by UNICEF RSPN

In rural Sindh, the poverty, lack of knowledge and unequal distribution of socio-economic resources has been the main contributors to increase child labour and encourage hazardous practices ultimately affecting the lives of children. In an attempt to eliminate child labour and present children with a better future, United Nations International Children Emergency Fund UNICEF decided to initiate a child rights project in cotton farming areas of Khairpur and Ghotki districts in Sindh province. The area is reportedly a cotton belt where a huge number of families and children are engaged in cotton picking and are victim of the exploitation and deprived of their main rights including right to education. This all ignorance and exploitation has led to a system where children lives have a lesser value and dark future.

In such a situation local community institutes' (CO/VO/LSO) came forward and RSPN and

Sindh Rural Support Organisation (SRSO) joined hands with UNICEF to promote child rights in these areas. The main deliverable of the project is to support families financially and impart knowledge through Multifunction community centers in order to create a congenial environment around children. Similarly in partnership with the different stakeholders including community institutions children are brought back to schools and all form of hazardous practices in cotton farming areas are discouraged. The grants helped families to improve their economic status whereas MFCCs became platform of knowledge as various sessions from tool kits delivered, capacity building sessions and community meetings held in these centers through inclusive approach. The children were also key stakeholder as they were made equal partner in decision making and they identified different interventions under the social funds activity.

Administration Department:

Administration department is the backbone of an organization. The daily functions of operating an organisation require time, precision and expertise. Office administration & Logistic services are the key elements associated with a high level of workplace productivity and efficiency. At the outset of FY-2015-16, SRSO administration department
