



## Call For Tender

Sindh Rural Support Organization (SRSO) is a not-for-profit organization incorporated on May 29, 2003, and registered under Section 42 of the Companies Act, 2017. SRSO is funded by the Government of Sindh and works in designated districts of Sindh with the objective of poverty reduction through community empowerment, skills enhancement, capacity building, and development of community-supported infrastructure projects.

SRSO invites sealed bids from eligible, registered, and experienced firms/service providers for the provision of rental vehicles for project operations in Thatta, Sujawal, Badin, and Sanghar districts.

### 1. Details of Required Vehicles

### 2. Scope of Services

The selected service provider shall be responsible for:

- Providing operational, roadworthy, and registered vehicles throughout the contract period.
- Providing drivers with valid driving licenses, Ensuring routine maintenance, repairs, and lubricants. Ensuring vehicle replacement in case of breakdown.
- Compliance with all applicable traffic, labor, and safety laws.

### 3. Eligibility Criteria

Interested bidders must meet the following minimum eligibility requirements: documentary evidence will be required.

- Must possess a valid NTN and Sindh Sales Tax (SST) registration.
- Must have relevant experience in providing rental vehicle services.
- Must not be blacklisted by any public or private organization. Supported with Affidavit.

### 4. Bid Submission Requirements

The bid shall consist of Single Envelop Single Stage.



Proposal shall include:

- Monthly rental cost per vehicle
- Total cost for 10 months
- Applicable taxes clearly shown
